Tridium, Inc. Named One of Virginia's Fastest Growing Technology Companies in Deloitte's Technology Fast 50 Program

Richmond Based Company Ranks in the Top 10 Across Virginia for the second consecutive year

Richmond, VA October 13, 2004 — Tridium, Inc. has been named to Deloitte's prestigious "Technology Fast 50" for the second consecutive year for the Virginia and Maryland region. The Technology Fast 50 is a ranking of the fastest growing technology companies in the two-state area. Rankings are based on the percentage of growth in fiscal year revenues from 1999-2003. Tridium's 1,120% increase in revenues resulted in a ninth place ranking in Virginia. Tridium is one of only four companies outside of the northern Virginia technology corridor to be recognized.
